Hello and thank you for your interest in the FSP Yoga Therapy Practitioner Training Programme.

I am trying to keep the application process as simple as possible but realise that certain things need to be covered. So hopefully this will not be too complicated or demanding.

So here we go:-

- The FSP requires applicants to have completed a Nationally Accredited Yoga Teacher Training Programme or the equivalent through an acceptable/approvable Yoga Training Body.
- I am continually reviewing which Nationally Accepted Accredited Teacher Training courses would qualify. For example any **BWY** Teaching Diploma holder would be acceptable.
- Some applicants may also need to attend a FSP interview as part of the evaluation process at the Yoganjali Practice and Teaching Centre in Bristol with Paul.
- This will take the form of attending a minimum of a cYs Introductory Weekend Workshop or maximum of a full cYs Foundation Course. This offers the opportunity for us to meet as part of the weekend and work together. It could also offer a useful opportunity for you to get a feel of how the Programme will be structured as well as learning and the foundational priorities within this approach and appreciating the Bristol Yoga Centre that will be our base.
- All applicants will be contacted and successful students will be advised regarding acceptance pre-requisites and course registration. Meanwhile any queries can be discussed with Paul.
- Before application and consideration for a place within the FSP, the student must hold a valid British Wheel of Yoga membership before applying.
- You will also need to consider an acceptable personal teacher for individual lessons and specialist personal supervisor for your group and 121 supervision hours as a further support for the Course. I am happy to offer my services for if required.
